The Global Initiative on Decent Jobs for Youth

The challenge

Today, over 66 million youth are without a job globally and nearly 145 million youth are working, yet living in poverty. These figures embody a massive waste of potential and a threat to social cohesion. Despite the sweeping recognition about how vital it is to invest in both the quantity and the quality of jobs for youth, efforts remain fragmented and low-scale.

The response

Decent Jobs for Youth is the global initiative to scale up action and impact on youth employment under the 2030 Agenda for Sustainable Development. Launched in 2016, with the endorsement of the executive heads of the United Nations, Decent Jobs for Youth is a unique platform to address fragmentation and catalyse effective and innovative action at country and regional levels.

An inclusive alliance of multiple partners

Decent Jobs for Youth brings together the resources and expertise of multiple partners to create linkages that maximize the effectiveness of youth employment investments, recognizing the key roles of governments, social partners, the UN System, youth and civil society, the private sector, regional institutions, parliamentarians, foundations, academia and the media. Partners subscribe to 15 guiding principles, which set the basis for effective, collaborative action.

The strategy

The strategy of **Decent Jobs for Youth** relies on four inter-connected elements:



Building a strategic alliance to advocate, ensure policy convergence, stimulate innovative thinking and mobilize resources



Scaling up evidence-based action and impact across key thematic priorities in line with the 2030 Agenda for Sustainable Development




Sharing and applying knowledge by capturing, analysing and sharing best practices, highlighting innovative approaches and facilitating learning



Mobilizing resources by securing high-level commitments from national, regional and international actors

Priorities for action

Responding to today's most pressing challenges faced by young people in the world of work.



Our achievements and the road ahead

After the launch in 2016 and with the commitment of 22 entities of the United Nations, Decent Jobs for Youth set in motion working groups to advance the strategy.

During 2016, the United Nations partners set the foundations of the strategic multi-stakeholder alliance, the engagement principles and key communication elements of **Decent Jobs for Youth**. Active and purposeful inter-agency collaboration has been a constant asset of the partnership and a flagship for multi-sectoral collaboration accelerating progress towards the achievement of the Sustainable Development Goals (SDGs).

In 2017, partners of **Decent Jobs for Youth** launched thematic plans of action <u>anchored</u> in rigorous and empirical evidence. The plans highlight what works, identify innovations, and offer concrete ideas to scale up action and impact across the key topical areas, namely:

1. Digital skills for youth

- 5. Youth entrepreneurship and self-employment
- 2. Quality apprenticeships
- 6. Youth transitioning to the formal economy
- 3. Youth in the rural economy
- 7. <u>Youth in fragile situations</u>
- 4. Green jobs for youth

With a concrete value proposition, Decent Jobs for Youth launched its engagement platform, expanding the alliance with strategic partners from governments, social partners, youth and civil society, private sector and beyond.

The engagement platform, www.decentjobsforyouth.org, launched in November 2017, is centred on the commitments of partners to take joint action on youth employment at local, country, regional and global level in line with the Global Initiative's strategy and guiding principles. Commitments towards Decent Jobs for Youth are recognized as direct contributions to the UN Partnerships for SDGs.

With 22 UN entities at its nucleus, **Decent Jobs for Youth** has grown today into an inclusive multistakeholder alliance, encompassing over 20 pledges for action that aim at improving the quantity and the quality of jobs for over 16 million young women and men around the world.

Moving forward the focus is on scaling up action and impact at country level.

In 2018, with the catalytic support from the governments of Spain and Luxembourg, **Decent Jobs for Youth** will be translating evidence into action at country level. To support scalability, partners will direct efforts towards identifying **innovations that work**. This effort includes initiating a conversation about innovative financing for youth employment and exploring cutting-edge mechanisms with potential for wide replication and high impact on labour market outcomes of youth.

- PARTNERSHIP: Create an open space for collaboration and networking under the 2030 Agenda for Sustainable Development, launch new commitments for Decent Jobs for Youth, and highlight how existing commitments translate our guiding principles into action.

- Co-designed expert sessions on innovative action and innovative financing for decent jobs for youth.
- Launch of new partner commitments towards Decent Jobs for Youth.
- One-on-one networking opportunities and Media Zone on Decent Jobs for Youth.

The event will provide a global platform for governments, social partners, youth and civil society, private sector, UN entities and beyond to foster collaboration on Decent Jobs for Youth under the 2030 Agenda for Sustainable Development.
