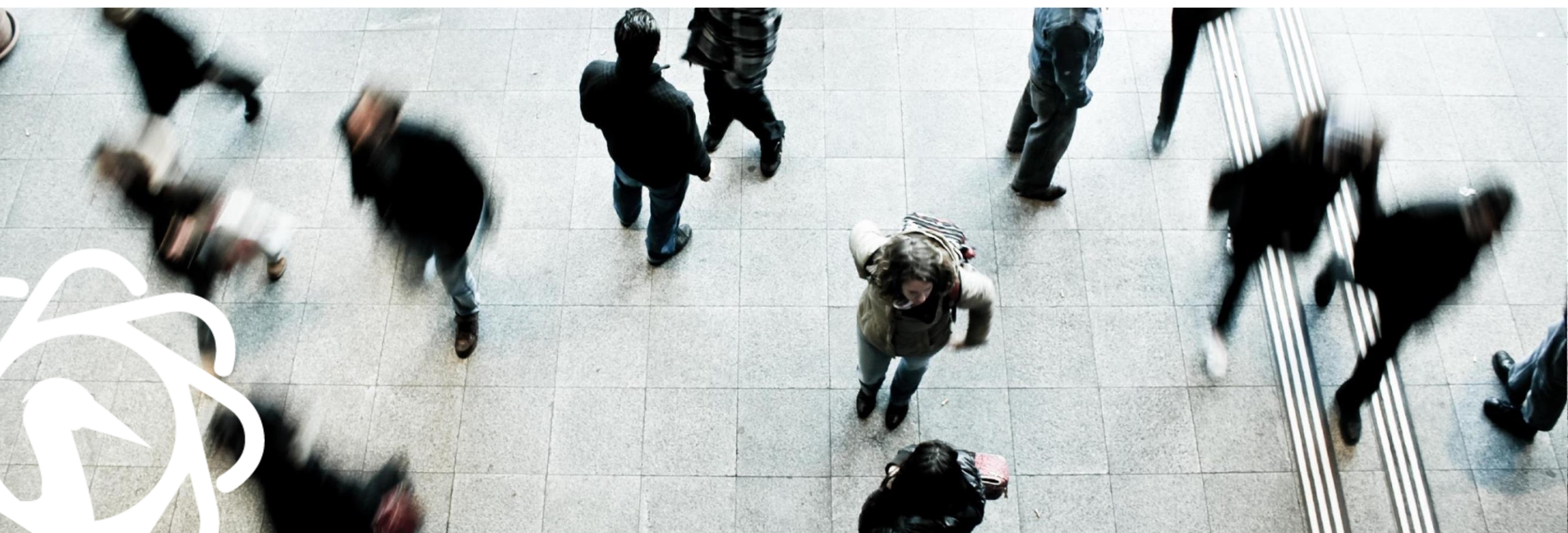

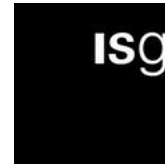

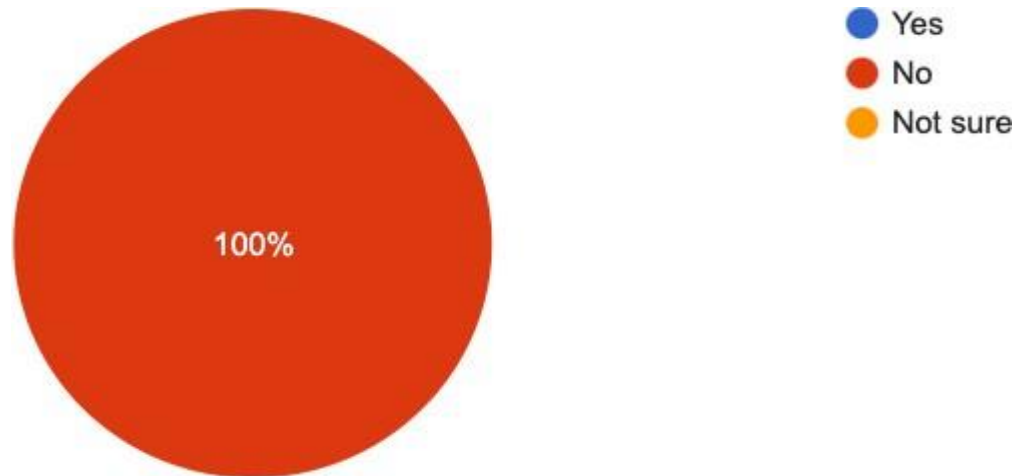
Launched Surveys: Snapshot of the Gaps in Understanding thus far

- The need for increased collaboration



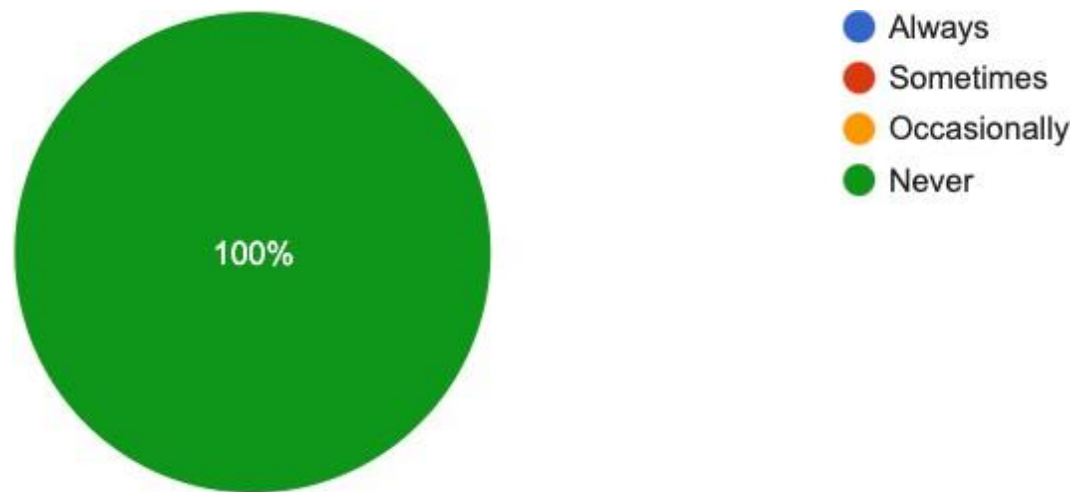
Snapshot 1 – lack of KPIs

- Have you made use of key performance indicators to quantify the effectiveness of measures taken by your company to mitigate the effects of child labour in your supply chain?



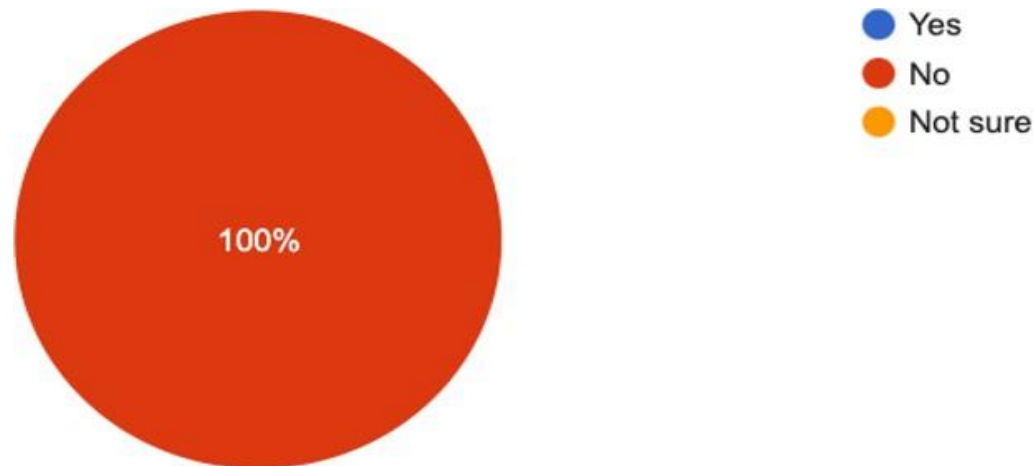
Snapshot 2 – lack of community engagement

- Does stakeholder or community engagement form part of your company's process in developing policy and effective solutions to the issue of child labour in your supply chain?



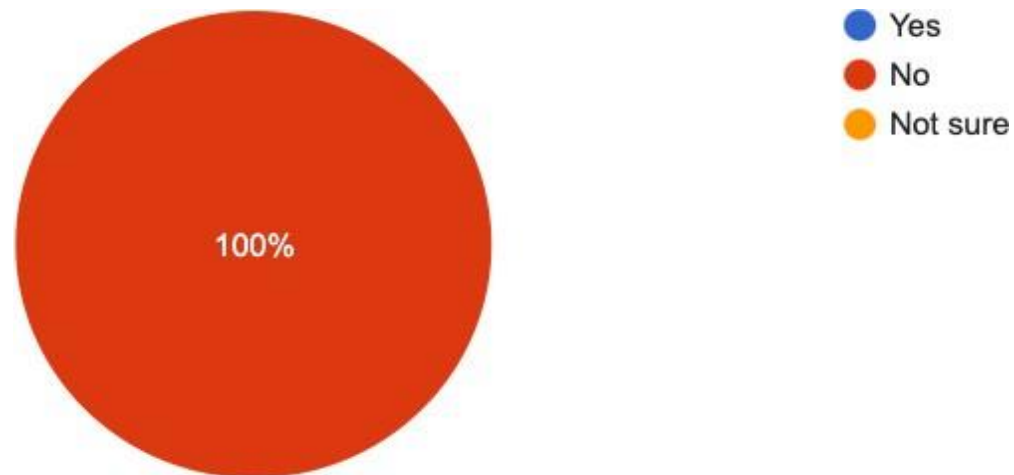
Snapshot 3 – the need for social initiatives
